POSTMARKS SHALL NOT APPLY. FAX OR EMAIL SUBMISSIONS WILL NOT BE ACCEPTED.** Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to LCRC.
